

- (c) To establish, construct and maintain medical colleges, colleges of nursing and physiotherapy, hospitals providing medical relief to any kind of ailments, nursing homes and physiotherapy centres and institutions for the relief of the sick and to aid or assist the other institutions and societies doing similar work;
  - (d) To spread knowledge and education by teaching and by publishing books, classics and other literature and distribute them freely or as prizes and/or by establishment of specific endowments or memorials for public charitable purposes;
  - (e) To establish professorships, lectureships and to aid by giving scholarships and prizes or any other similar help or encouragement for the advancement of education, research and training;
  - (f) To establish, maintain and support and assist by monetary gifts or otherwise, charitable institutions such as charitable dispensary, hospitals, infirmary, convalescent home, maternity home, nursing home, homes for the blind, deaf and dumb, home for lepers and other charitable institutions having similar objects for medical relief;
  - (g) To provide medical relief by giving free medicines, injections, tonic, food and the like and by giving help for medical treatment including payment of expenses for such medical treatment;
  - (h) To establish, maintain, support and assist by giving monetary gifts or otherwise and to aid and promote homes and model institutions for the crippled, incapacitated, unemployed and illiterate men, women and children and to teach them handiorafts and cottage industries so as to enable them to become useful to the society;
  - (i) To erect or help in erecting building or otherwise provide housing accommodation for the poor and to establish and maintain sanatorium, public halls, community halls reading rooms, lecture halls, auditorium, educational and research institution and the like in any part of the country and to provide convenience to the persons visiting such places;
  - (j) To propagate effectively the advantage of family planning, polio immunisation and control measures against AIDS among the public;
  - (k) To establish or help in the establishment or support and maintenance by donation or otherwise of any technical institutions and research in the field of medicines for the benefit of the public;

- (m) To aid for the general improvement and promotion of agriculture, medical sciences, bio-technology, horticultureand the like and for research in those subjects;
- (n) To take steps to disseminate scientific, technical and cultural knowledge and to raise the standard of life and health among the backward sections of the people;
- (o) To conduct lectures, seminars, workshops, symposiums and other media of propagation on all subjects particularly in the field of education and health and to award scholarships, prizes or trophies for the advancement of the above objects;
- (p) To construct new wells and maintain and repair existing wells, tanks and other sources of water for the benefit of the public and to give monetary help for the same;
- (q) To give monetary aid or other help for relief from natural calamities like floods, cyclone, tempest or otherwise;
- (r) To assist renovation of places of historic, archaeological or artistic importance;
- (s) To educate the public on Indian Philosophy and to promote the spirit of brotherhood by giving oral tuition and practical training.
- (t) To collect and maintain a fund for the objects and purposes of the Trust and in particular to accept donations and gifts of properties - movable and immovable - assignments of life insurance policies.
- (u) To do all such things as may be necessary or conductive for the advancement of any other objects of general public utility not involving any activity for profit.
- (v) The funds of the Trust shall be applied for the aforesaid objects only in India.

## 5. Irust Fund

- The FOUNDER AND AUTHOR OF THE TRUST declares that a sum of Rs.1,001/- (Rupees one thousand one only) has been dedicated by him for public charitable purposes and objects of general public utility described as above and the Trustees shall and will stand possessed of the said sum of Rs.1,001/~ (Rupees one thousand one only) upon trust and also any other properties, whether movable or immovable, which the Trustees may, from time to time, receive for augmenting the objects of the Trust or for special purposes connected, with the objects of the Trust, not calculated to impede the due working of the Trust arising from donations, requests or from any other sources whatsoever and also of any investments for the time being representing the same (hereinafter referred to as "TRUST FUND") and also of the net income from the Trust Fund into trust, and apply both the income and the capital of the Trust Fund for the purposes of the Trust;
- The Trustees hereby acknowledge the receipt of the said sum of Rs.1,001/- (Rupees one thousand one only) dedicated by the FOUNDER AND AUTHOR OF THE TRUST;
- It is hereby declared that as on date, the Trust does not own any immovable properties.
- Administration of the Irust The administration of the Trust vests in the Board of Trustees.
- (a) Board of Irustees: The Board of Trustees shall have a strength of not less than FOUR and not more than TWELVE members. The First Trustees will be:
- (i) Smt. G.N.PONNAMMAL wife of Late P.Chinnasamy, aged about 75 years, residing at No.1, First Trust Link Street, Mandaveli, Chennai 600 028.
- (ii) Sri C.RAMACHANDRAN, son of Late P.Chinnasamy, aged about 50 years, residing at No.1, First Trust Link Street, Mandaveli, Chennai 600 028.
- (iii) Sri C.DAMODARAN, son of Late P.Chinnasamy, aged about 45 years, residing at No.1, First Trust Link Street, Mandaveli, Chennai 600 028.
- (iv) Smt. D.JAYAKARTHIKA, wife of C.Damodaran, aged about 30 years; residing at No.1, First Trust Link Street, Mandaveli, Chennai 600 028. '
- (v) Sri K. SUBRAMANIAN, son of Gangachalam, aged about 32 years, residing at No.26, Adanjan Street, Mandaveli,

(b) The aforesaid persons have agreed and accepted to be the First Trustees of the Trust and Smt.G. N. Ponnammal shall be the Managing Trustee. The Managing Trustee shall be entitled to nominate his/her successor as Managing Trustee and also to nominate in the place of the co-trustees any person as Trustee in the event of there being a vacancy arising in such place, either by resignation or death or of any other cause.

- (c) The First Trustees shall hold their office till their life time unless any of them vacates by death or otherwise his office of trusteeship earlier. Should there be any vacancy in the office of the Trustees for any reason on cause whatsoever, suitable members shall be co-opted as Trustees by the Managing Trustee. In any case, the first Trustees can co-opt any other Trustee to the Board of Trustees as they may donsider fit and proper.
- (d) The trustees shall have sub-committees as and when necessary to manage schools, institutions, hospitals and other institutions run by the power to appoint Trust and any such sub-committees so appointed, the Managing Trustee shall be ex-officio Chairman.
- Powers of the Irustees general powers of the Trustees to manage the Trust, the Trustees shall have the following powers of management and administration of the Trust and for the execution of the objects of the Trust :-
- (a) To keep the Trust properties or apply the Trust Fund for the acquisition of any kind of property whatsoever including movable and immovable;
- (b) To open one of more bank accounts in the name of the Trust anywhere in India and to operate the same;
- (c) To invest funds of the Trust in any movable or immovable property in any part of the country and to sell or vary such investments according to their discretion from time to time.
- To sell, mortgage, lease or create any charge on the whole or any part of the property of the Trust for attaining the objects of the Trust in their absolute discretion;
- (d) To execute such power of attorney or atterneys in favour of any person or persons for the purposes of executing and administering the whole or any part of the Trust and to delegate his powers to such attorney or attorneys only for the purpose of conveniently, efficiently and advantageously administering the properties of the Trust and for the PadmaSnmvasan



- (f) To do all such acts and things as are necessary for the dontrol and management of the affairs of the Trust and for purposes of attainment of the objects of the Trust;
- To raise loans from Banks, Financial Institutions or other institutions providing such facilities for the benefit of the Trust and to sign such promissory notes, bills of exchange, hundles or any other financial documents that may be necessary for and on behalf of the Trust;
- To settle, compromise or compound all and any of the debts, claims, outstanding amounts, disputes, demands, auctions, suits and proceedings whatsoever by or against in any manner relating to the Trust or refer the same to
- To incur all such expenses as are necessary for the (i) execution of the Trust under the powers of these presents;
- To co-opt one or more Trustees with liberty of such option and to increase the members of the Trust, subject to the condition laid down in clause 7(c) above;
- (k) To make, alter, rescind the rules and regulations for the management and administration of the Trust;
- To receive donations or accept gifts or contributions in cash or in kind and issue feceipts for the same;
- (m) To appoint auditors to audit the accounts of the Trust;
- To appoint legal advisers for the trust;

- To appoint any employees, agents, managers, clerks, peons or other servants necessary for any of the purposes aforesaid at such remuneration, commission or salary as the Trustees may think proper and from time to time to dismiss or discharge such agents, managers, etc. and to appoint and employ others in their place.
- Meeting of the Board of Trustees The meeting of the Board of Trustees shall be held as and when required and the Managing Trustee is empowered to convene the meetings. quorum for such meetings will be THREE. Any decision taken by the Board at its Meeting will be by majority of votes.
- The Trustees shall maintain proper books of accounts of the moneys, properties and income and expenditure of the Trust and get the same audited by a Chartered Accountant The audited accounts and the financial every year. statements shall be placed before the Board of Trustees and shall be approved and adopted by them.

- The Official year of the Trust shall until the 11. Trustees otherwise resolve, be from 1st April to 31st March of the succeeding year. The first year of account shall commence from the date of these presents to 31st March, 2001.
- The investment of the Funds of the Trust shall be in accordance with the provisions of section 13(1)(d) read with section 11(5) of the Income-tax Act.
- If the objects of the Trust for which the Trust has been created shall fail and cannot fulfill, on account of dissolution of or winding up of the Trust, the Trustees shall ~ be at liberty to transfer the Trust Fund and the properties of the Trust to other trusts or institutions having similar objects.
- 14. The funds of the Trust shall be utilised towards the objects of the Trust and no portion of it will be utilised for payment to the Trustees/members by way of profit, interest, dividend etc.
- The funds of the Trust would not be applied for any religious purposes or given to religious institutions.
- The activities of the Trust would be purely charitable nature not motivated for profit.
- 17. Alienation of immovable property shall be done with approval of the prior Director of. Income-tax (Exemptions), Chennai.
- 18. The benefits of the Trust shall be open to all irrespective of caste, creed, religion and sex.
- 19. Any amendment to the clauses of this Deed of Trust shall be carried out with the approval of the Director of Income-tax (Exemptions), Chennai.
- 20. | The Trustees shall at all time stand indemnified in respect of any act that may have been done bona fide by them in respect of matters relating to the Trust.
